Representative

- Eyes & Ears
- Not empowered to make decisions that affect you financially
- Reports back to primary customer for decisions
- Not aware of your Terms with the refiner

Agent

- Proxy for the customer
- Empowered to make financial decisions
- Makes decisions without direct input from the primary customer
- May be aware of refiners terms

Representative Overview





- Supervision of material receipt
- Chain of custody for processing
- Verification of all weights and measures
- Confirmation of material recovery from all equipment and processes
- Integrity of Sample(s) for valuation and settlement
- Reconciliation of all process data with refiner site for final settlements
- Reporting to customer of any anomalies, process deviations, issues, or errors!

Trust is missing in the relationship

- Client may feel they are not getting a fair deal from their refiner
- Prior bad experiences with sampling methods or equipment
- This is most difficult place to build trust from





Establishing a new relationship

- Unfamiliar with Refiner's sampling systems or methods
- New product or market for the customer
- Details intensive in scope





Good Practices

- Prior experience has shown good results
- Maintains process oversight, and verifies all details.
- Becomes a routine business process





Business Requirements

- Driven by compliance, HSE, risk management, etc.
- Highly structured in scope and delivery
- Risk of becoming a box ticking exercise





Business Requirements

- Driven by compliance, HSE, risk management, etc.

1. Knowledge of processes and sampling

- If you could be there every time you would!.
- Representation companies are knowledgeable about sampling in general as well as site specific sampling.
- It's all about the sample, everything hinges on that being right.



Building Trust











A lot of value can be tied to a few samples

- Most likely if you could be there for every shipment, you would.
- Verification the refiners process is repeatable, reliable, and transparent (within the bounds of intellectual property)
- Chain of custody on material and samples is always maintained



Building Trust











With a Rep all parties are on the same page

- Expectations are clearly defined and sampling plan agreed
- Everything from weights to seals to references are verified and confirmed
- Any anomalies or deviations are documented and agreed by all parties before proceeding



Building Trust











It's a 2 way Street

- Memory can be faulty, independent documentation can quickly resolves discrepancies
- Small errors don't compound and delay settlements later
- Highlights improvements that benefit both parties



Considerations in a Representation Company









- Network: Are they everywhere you want to be
- Experience with product
- Experience with location
- Employees vs Subcontractors
- Scope of on-site service offered: Partial or Full
- Laboratory Service offered?
- Reputation
